REQUEST FOR PROPOSALS - SECTION 5310

One application for funding in response to the County's Request for Proposals for eligible transportation providers to apply for Federal assistance under 49 U.S.C. Section 5310, Formula Grants for the Enhanced Mobility of Seniors and Individuals with Disabilities Program was received. The application submitted was from Malheur Council on Aging & Community Services (MCOA&CS) and it has been reviewed and deemed complete. Commissioner Jacobs moved to accept Malheur Council on Aging & Community Services Section 5310 Application. Commissioner Hodge seconded and the motion passed unanimously.

ROAD ACCEPTANCE

Commissioner Hodge moved to approve 2021 Intergovernmental Agreement (IGA) for the Financing of Community Mental Health, Addiction Treatment, Recovery, & Prevention, and Problem Gambling Services, Agreement #166050. SENATE BILL 16

Staff explained an inquiry had been received asking if the Court would be interested in writing a letter or passing a resolution in support of Senate Bill 16 sponsored by Senator Lynn Findley. The bill would allow the county to partition and rezone up to 200 acres of lands within the Eastern Oregon Border Economic Development Region from exclusive farm use to residential uses. The Court indicated they were supportive of the bill.
