## <u>PUBLIC HEARING - SUPPLEMENTAL BUDGET</u>

A public hearing was required as the supplemental budget will adjust the current budget fund by 10% or more of the expenditures of that fund. No public comments were received. The hearing was closed. Commissioner Hodge moved to approve Resolution R21-30: In the Matter of Fiscal Year 2021/2022 Supplemental Budget by Resolution Under Local Budget Law ORS 294.471. Commissioner Jacobs seconded and the motion passed unanimously. The purpose of the supplemental budget is to Allocate Contingency Funds to MCSO Communication Center - these are holdover funds from the Homeland Security Grant for the Dispatch Center.
