<u>LIFEWAYS</u>

- Crisis services and dispatch are being rolled out. Pilot testing dispatch now in house. This will have a local response. Currently on 2nd week and working out kinks. Will send out more info when finalized.
 Will be available to all community partners. This will be 24 - 7 days a week.
- Mobile crisis response is also rolling out. Have secured a vehicle.

Wendy asked if this would be for all ages. As of now, there will be no age restrictions. Will roll out MH first and then a SUD component later.

Wendy also asked about staffing. Staffing is always a challenge. Will always have at least two individuals on call and available. Wendy asked if Lifeways would be looking at other community partners to assist.

✓ Dr. Liu will look into this and reach out.

Rebecca asked whom would they reach out to for a client or staff if they are in danger of harming themselves. Rebecca also stated that the recent crisis they have at the Health Department – to say Lifeways was awesome with their response.

Jenn asked if the mobile crisis would travel outside of Ontario. Christopher Liu stated the CMHP is over all of Malheur County. It may take a little more time outside of Ontario in rural areas. Dr. Liu will have more information in the next couple of weeks regarding the crisis team. He feels we need to be more proactive as a team. Hope to see more funding from the state level.

- o Crisis center- still actively looking for funding. Team is looking for land to build crisis center.
- Lifeways is actively looking for new board members. Dr. Liu asked if any of this team has any interest or
 if they know of anybody that would be interested.
- We are currently expanding our peer center. Looking for space. Dr. Liu asked if anybody knows of any to please reach out. This would be just for adults now, but also looking into a space for children down the road as well.
- Lifeways will be conducting some crisis incident stress management trainings. His is asking if anyone from this team would like to attend the training. CISM hope to have all Lifeways staff trained in next two weeks. If interested reach out. Some of this training is self-guided. There are two components. This is a twenty-hour training. Everyone on this meeting is asked if they would like to attend. Reach out to Dr. Liu if interested.

Christine joined the meeting at 1:51 pm MT.

- Big change in leadership at Lifeways.
