Also, on page 7, under County Code 6-6-7(2)(c), where it says, "The dwelling will be sited on a lot or parcel created before January 1, 1993" I'm going to go ahead for the record and read through the change of that and what Stephanie changed this to as well.

It now says, "A property line adjustment established the current location/boundaries of the property, which was administratively approved on August 17, 2018. The property does not qualify for a non-farm dwelling under ORS 215.281. The property is not a lot or parcel as defined in ORS 215.010 or ORS 92.010 created before January 1, 1993."

"Applicant's reference to ORS 215.284(7) as authority in this matter is misplaced and does not apply. ORS 215.284(7) applies to partitions to site non-farm dwellings (not property line adjustments to site non-farm dwellings) in the exclusive farm use zone."
