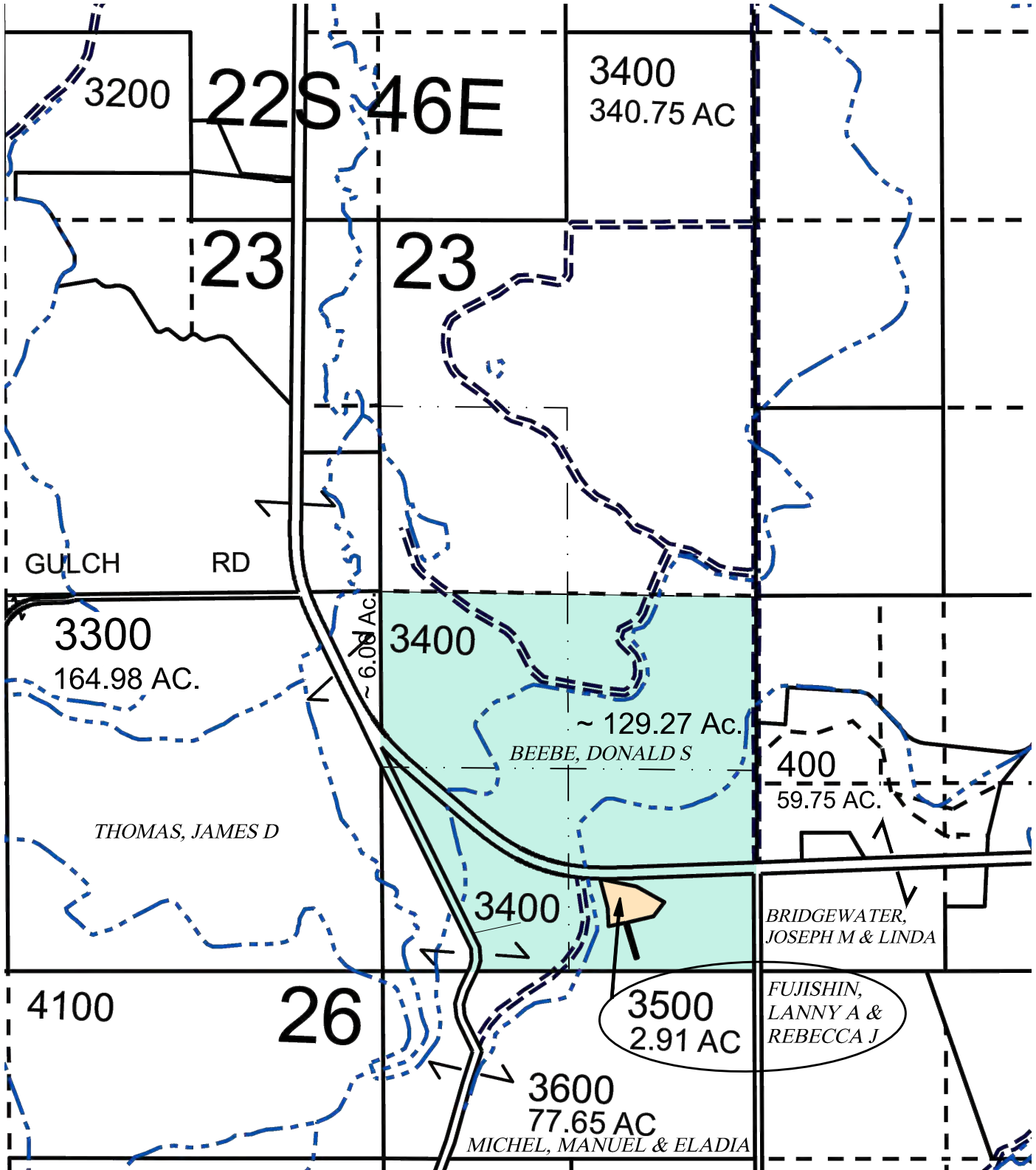

Tax Lot 3400 - BEEBE, DONALD S

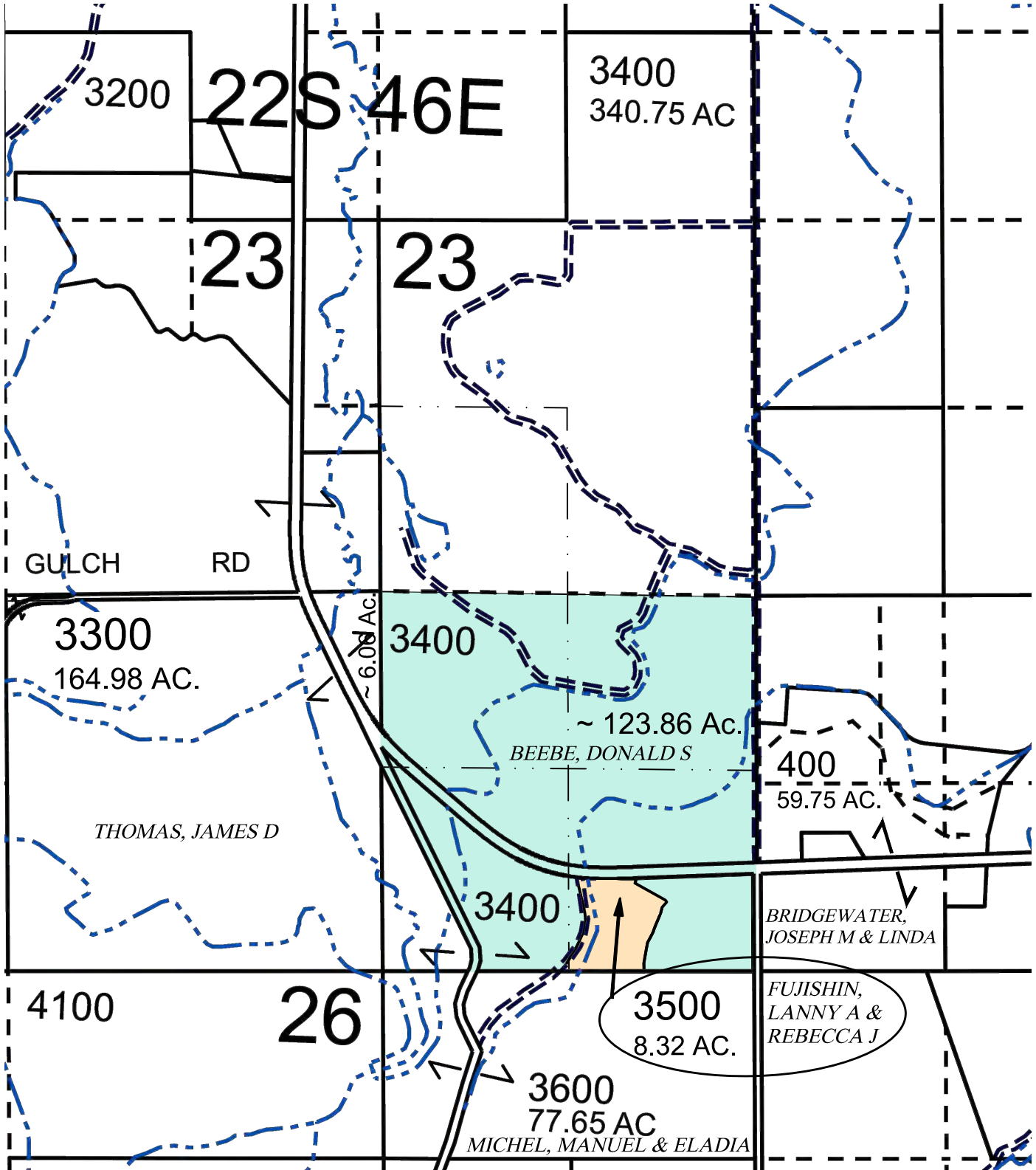
