Ms. Burgess,

The Department of Geology and Mineral Industries (Department, DOGAMI) would like to provide comments on the proposal by Mr. Darren Lee for a gravel pit on tax lot 3200 on Assessor's map #16S47E.

DOGAMI issued a Suspension Order (SO) to Darren Lee on March 8, 2023, for surface mining without an operating permit. On March 14, 2023, DOGAMI issued a Notice of Violation and Compliance Order (NOV/CO) requiring restoration of the surface disturbance conducted without an operating permit. These orders are enclosed as part of the Department's comment.

On March 20, 2023, Mr. Lee requested an informal review by the State Geologist of the SO and NOV/CO and the orders were upheld. Mr. Lee then engaged counsel and agreed to comply with the NOV/CO and requested clarification of the Departments expectations on April 25, 2023. The Department provided additional guidance on June 22, 2023 (enclosed), and established a new due date of September 30, 2023, which was not met.

Mr. Lee, via their counsel, continues to challenge the requirement to restore the roads constructed. Mr. Lee is not complying with the NOV/CO and has not provided the requested documentation of work completed. The Suspension Order will remain in effect until withdrawn by written order of the Department.

The Department of Geology and Mineral Industries (DOGAMI, Department) has received multiple complaints accompanied by photos and videos alleging 4 Lees Excavation is mining without a permit on Township 16S Range 47E, Tax Lot 3200. DOGAMI contacted the Malheur County Planning Department regarding these complaints and was informed that Darren Lee applied for a Post Acknowledgement Plan Amendment for this parcel and that it was denied by Malheur County Court in August of 2021. Further, DOGAMI was informed that a citation had been issued to the landowner, Mr. Dallas Head, for mining in the EFU zone. In addition to the evidence already cited, review of publicly available aerial imagery indicates Darren Lee and 4 Lees' Excavation have conducted surface mining on Township 16S Range 47E, Tax Lot 3200 in violation of ORS 517.790(1).

The Department hereby issues this Suspension Order pursuant to ORS 517.880(2) which authorizes DOGAMI to suspend operations if the operator is conducting a surface mining operation for which an operating permit is required but has not been issued.

Effective immediately you are ordered to suspend all surface mining operations at the property referenced above, including removal of vegetation, construction of berms, stripping of topsoil or overburden, extraction, processing, and the removal of stockpiled materials.

This Suspension Order remains in effect until withdrawn by written order of the department. If you fail to comply with the Suspension Order, the department intends to take further enforcement action against you. This may include, but is not limited to, assessing civil penalties under ORS 517.992, or referring this matter to the Attorney General to initiate legal proceedings as provided in ORS 517.880(3).

In addition to the evidence already cited, review of publicly available aerial imagery indicates Darren Lee and 4 Lees' Excavation have conducted surface mining on Township 16S, Range 47E, Tax Lot 3200 in violation of ORS 517.790(1).

Per ORS 517.790(1) an Operating Permit is required for any surface mining operation started after July 1, 1972.

Therefore, the department finds that:

1. The operator is in violation of ORS 517.790 for engaging in surface mining on land not surface mined on July 1, 1972 without holding a valid Operating Permit.

The following corrective action is required:

You are required to <u>restore</u> all surface impacts by Darren Lee and 4 Lees' Excavation on Township 16S Range 47E, Tax Lot 3200 to a stable, <u>pre-mining condition</u> by **June 15, 2023**. These impacts include expansion of the previously exempt mining disturbance in the southwest corner of the parcel, the new road constructed connecting Mesquite Rd. to Jasmine Rd., stripping of vegetation and topsoil, construction of berms, test pits, and any other surface disturbance conducted for exploration or in preparation for mining.

If you fail to comply with this Notice of Violation and Compliance Order, the department intends to take further enforcement action against you. This may include but is not limited to the assessment of civil penalties for the violation of this order.

Mr. Sheets,

The Department has prepared this letter in response to your letter dated April 25, 2023, in which you conveyed that your client wishes to complete the corrective actions required in the Notice of Violation and Compliance Schedule issued March 14, 2023. The letter also requested clarification of the Departments expectations and guidance to move forward with restoration while maintaining compliance with the Suspension Order.

Regarding your client's concerns about violating the Suspension Order issued March 8, 2023, Mr. Lee is required to perform any activities that are necessary to comply with the reclamation requirements. The Department will communicate to the neighbors that such activity is required by DOGAMI.

To alleviate any confusion on your client's part, the Department has prepared the enclosed aerial map with each area of concern delineated. The delineations are approximate and intended to assist your client in identifying these areas on the ground. General guidance for acceptable methods to restore each feature identified in the legend is described below.

- Stripping and berming: The area where stripping was conducted to construct berms, and where the berms were constructed, is indicated on the map with a green dashed outline. In this area, berms should be leveled to cover the stripped areas, along with recontouring to match the pre-existing ground surface. Following this, replacement of growth medium matching the surrounding undisturbed field and revegetation with the pre-existing cover crop.
- Haul road development: The haul road is indicated on the map with a purple dashed outline. The haul road construction covers topography with different geometry and surrounding vegetation. Where the haul road was cut into the hillside with a switchback up the hill (starting at the north, just off Mesquite Rd) the side-hill cut and switchback should be filled and recontoured to the previous configuration and slope. Followed by replacement of growth medium to matching the surrounding undisturbed ground, and revegetation with native species to a similar density and composition of surrounding vegetation. Where the elevation levels out and the haul

road was cut into relatively flat ground to the south toward Jasmine Rd., the road needs regraded to previous contours. Following this, replacement of growth medium matching the surrounding undisturbed field and revegetation with the pre-existing cover crop.

- Pit excavation Pits are identified on the map with a dashed red outline and should be backfilled to the pre-existing ground surface. Following this, replacement of growth medium matching the surrounding undisturbed field and revegetation with the pre-existing cover crop.
- Quarry expansion The quarry expansion area is indicated on the map with a yellow dashed outline. In this area, any berms or stockpiles that were constructed should be leveled to cover stripped or disturbed areas, along with recontouring to match the pre-existing ground surface. Following this, replacement of growth medium matching the surrounding undisturbed field, revegetation with the pre-existing cover crop, and revegetation with native species to a similar density and composition of surrounding vegetation. Additionally, any pits that were excavated should be restored as described under Pit excavation above, plus revegetation with native species to a similar density and composition of surrounding vegetation.
- Pre-Existing Quarry The area the Department considers the pre-existing quarry is indicated on the map with a light gray dashed outline. The disturbance in this area occurred prior to the elimination of Grants of Total Exemption, which were a voluntary registration for mining occurring below the thresholds requiring an Operating Permit. Therefore, this area is not required to be reclaimed.

The Department recognizes the delay in providing this requested guidance and is providing an extension to September 30, 2023. A site inspection will be conducted to confirm reclamation is complete to the satisfaction of the Department.


