My expectations of such a fun, exciting and safe place will bring fulfillment to families.

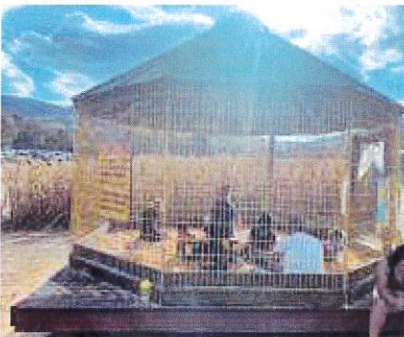
